Linda Colburn (Facilitator) Ms. Colburn has served as President since 2001 of Where Talk Works, Inc., a firm providing a range of technical assistance to organizations throughout Hawaii including mediation, group facilitation, public meeting management services, board retreats and strategic planning. Over the past 30+ years, she has held many leadership and administrative positions for nonprofits, for-profit and governmental entities including the Hawaii Nature Center (Executive Director), Office of the Governor, State of Hawaii (Felix Consent Decree Operations Manager), Office of Hawaiian Affairs (Administrator, Economic Development Officer), Aina Kupaa O Ma'ili, Inc. Ma'ililand Transitional Housing Project (Executive Director), Na OIwi O'ahu, Inc., Hawaiian Business Development Project (Executive Director). In the healthcare realm, she has supported planning, discussion, mediation and resolution of issues and legislative strategy development for organizations such as the Hawaii Health Connector, an O'ahu-based hospital, the Hawaii Primary Care Association, Native Hawaiian physicians, Hawaii Uninsured Project and the State Department of Health.

Donna J. Mills is Former Senior VP & CEO, Sharp Rees-Stealy Medical Centers, San Diego. In this position for 18 years, she led a staff of more than 2000 employees supporting the 500 physician multi-specialty medical group practices. Sharp Rees-Stealy covers more than 1.5 million visits annually at 22 locations throughout San Diego and is part of Sharp HealthCare, a fully integrated network of medical services, including four acute care hospitals, three specialty hospitals, a health plan and many ancillary support entities. Ms. Mills is an American College of Medical Practice executive, an MGMA fellowship candidate and has been honored as one of the "Women Who Mean Business" in healthcare by the *San Diego Business Journal*. She has served on many professional boards and committees including the CAPG Board of Directors. Ms. Mills is currently a healthcare consultant/advisor who lives in Kona, Hawai'i. She has been providing advice and consultation for the IPA including facilitating talks between EHI IPA and Hawaii Health Partners (HHP) in 2017. She also served as a facilitator for the IPA's 2017 Annual Symposium.

Barbara Spivak, MD, is a practicing internist who has served as President and Chairperson of the Mount Auburn Cambridge Independent Practice Association (MACIPA) since 1997. She serves as a Mass HealthQuality Partners (MHQP) Board member and was appointed to the AMA National Committee on Delivery System Reform in 2011. MACIPA is a physician membership organization with most of the physicians in small private practices, some owned by Mount Auburn Hospital or Cambridge Health Alliance. MACIPA provides support systems to help physicians manage population health, quality improvement, electronic health records and data exchange and analytics. Dr. Spivak graduated from Tufts University School of Medicine and completed her residency at St. Elizabeth's Hospital. She is a Clinical Instructor in the Department of Medicine at Harvard Medical School. Dr. Spivak has served as an East Hawaii IPA Symposium speaker and facilitator and has been an expert sounding board for the IPA for the past three years.

Leolinda Parlin currently serves as director for Hilopa'a's Family to Family Health Information Center in Honolulu, administering grant funding of over \$4.5M in the training of health care professions and support for families in the areas of neurodevelopmental disabilities and related disorders. Ms. Parlin has over 25 years of leadership in the areas of Medicaid, government financed programs, curriculum development and training with specific expertise in areas of health care systems, program evaluation and legislative advocacy. She has worked for and provided consultation to multiple state Medicaid programs, the Los Angeles County Hospital System, as well as the U.S. Department of Defense. She is Clinical Faculty to the John A. Burns School of Medicine, serves as the Principal Investigator for the Hawai'i Autism State Implementation Grant, the Co-Director of the Hawai'i MCH LEND Program, the Co-Chair of the Ka Huliau Medical Home Transformation Project and is the Ombudsman for the Hawai'i Medicaid Program. She has obtained over \$10,000,000 in federal grant funding for the state of Hawai'i in the last 10 years. Ms. Parlin works very closely with the State Legislature and Advocacy groups and has had three pieces of legislation pass into law. Annually, the federal Health Resources Services Administration (HRSA) engages Ms. Parlin to perform Title V Block Grant Reviews of the Pacific Trust Territories and Jurisdictions. Ms. Parlin was born and raised in Hilo and has served as a facilitator, content expert and advocate for East Hawaii IPA primary care family physicians and pediatricians for the past several years. Ms. Parlin also helped facilitate the awarding of a \$350K+ SBIRT (Screening Brief Intervention & Referral to Treatment) grant to EHI IPA.
