The [QPP Participation checking tool](#) now will give a predicted Qualified Participant (QP) status for those who are part of an Alternative Payment Model. MU (Meaningful Use)

News Flash:

The Medicare/Medicaid Electronic Health Record (EHR) Incentive program, formerly known as Meaningful Use, will now be known as Promoting Interoperability (PI). The new focus of the PI program is to be more flexible and less burdensome for providers, to improve interoperability and to improve patients' access to their health information.

The proposed changes to the PI program will **NOT** start until reporting year 2019. The high-level, proposed changes for PI will include (starting in 2019):

- Eligible participants must use 2015 edition of EHR certification
- Reporting period will be 90 days
- Changes to the clinical quality measure (CQM) sets to align with inpatient quality reporting (IQR) and core measure changes
- More emphasis on measures that require interoperability, exchange of health information between providers and patients

For the 2018 reporting period, eligible hospitals and professionals will continue to attest to the same requirements as they did in 2017. Please access our [recent blog post](#) for more detailed information about 2018 reporting.

Privacy and Security

News Flash:

Physical security is an important component of the HIPAA Security Rule that is often overlooked. What constitutes appropriate physical security controls will

depend on each organization and its risk analysis and risk management process.

While the latest security solutions to combat new threats and vulnerabilities get much deserved attention, appropriate physical security controls are often overlooked. Physical security controls remain essential and are often cost-effective components of an organization's overall information security program.

Hospitals

News Flash:

The submission deadline for the Hospital Consumer Assessment of Healthcare Providers and Systems (HCAHPS) patient perspectives on care survey data for first quarter (1Q) 2018 discharges (January 1-March 31, 2018) is July 5, 2018. The Centers for Medicare & Medicaid Services (CMS) strongly encourages all hospitals, whether they self-administer the HCAHPS Survey* or use a survey vendor, to submit data at least two days prior to the deadline to allow time to address any submission issues.

- Inpatient Prospective Payment System (IPPS) hospitals participating in the Hospital Inpatient Quality Reporting (IQR) Program must collect and submit HCAHPS data to qualify to receive their full Annual Payment Update (APU).
- Non-IPPS hospitals must meet the same submission deadline for their data to be published on Hospital Compare.

Review and Correction Period

The Review and Correction Period is July 6-12, 2018. Immediately following the July 5, 2018 data-submission deadline, participating hospitals and survey vendors have a seven-day opportunity, the July 6-12, 2018 Review and Correction Period, to access and review the HCAHPS Data Review and Correction Report. The report contains a summary of the data accepted into the HCAHPS Data Warehouse for the quarter. New data will not be accepted into the warehouse during the Review and Correction Period. Errors in data accepted into the warehouse by the July 5, 2018 deadline can be corrected. During this seven-day period, the corrected data can be submitted to the warehouse to replace incorrect data.

Readmissions

News Flash:

Hospital readmissions might be reduced more effectively if community-based readmission reduction strategies are added to ongoing, hospital focused improvement efforts. Human and social services are working in communities, but there continues to be almost no communication between many key service providers.

Other key issues include:

1. Major gaps in social service delivery programs, especially for the most vulnerable populations, including the homeless, the mentally and physically disabled and the aging and elderly.
2. Virtually no options for services available in most rural communities.
3. Services that do exist in rural communities are highly inaccessible.

Finally, we need to address and implement strategies that empower the population to make informed decisions about health care and long-term care options. We also need to ensure these options are accessible.

ADEs (Adverse Drug Events)

News Flash:

Are your patients buying medication online?

On June 5, 2018, the U.S. Food and Drug Administration [announced](#) that it has warned nine online networks, operating a total of 53 websites, that they must stop illegally marketing potentially dangerous, unapproved and misbranded versions of opioid medications, including tramadol and oxycodone. This follows a [February 2018 report from the National Association of Boards of Pharmacy®](#) (NABP®) that found 54 percent of reviewed sites were selling controlled substances, up from 13 percent of sites in the previous nine years. They also found 98 percent of these sites did not require a valid prescription. Patients who buy prescription medicines from illegal online pharmacies may be putting their health at risk because the products, while being marketed as authentic, may be counterfeit, contaminated, expired or otherwise unsafe. In fact, 50-62 percent of medicines purchased online [are fake or substandard](#).

[BeSafeRx](#) is a national campaign to raise awareness of the dangers of buying prescription medicines from fake online pharmacies. This campaign provides resources to help consumers:

- Learn the dangers of buying from a fake online pharmacy.
- Identify the signs of a fake online pharmacy.
- Find a safe online pharmacy.

[The .Pharmacy Verified Websites Program](#) helps identify safe websites from around the world to purchase medication or to find medication-related information and services. It is operated by the National Association of Boards of Pharmacy®, the impartial professional organization that supports the state boards of pharmacy in protecting public health. Only verified websites are allowed to use .pharmacy, ensuring these websites are properly licensed and have met [program standards](#).
