Overview: On January 1, 2019 Hawaii enacted the Our Care, Our Choice Act: the compassionate authorization of medical aid in dying for the terminally ill, mentally capable adults with six months or less to live. The Compassion & Choices National Medical Director, Dr. David Grube will provide information on the clinical competencies, pharmacy role and medication protocols involved in all end-of-life choices with particular emphasis on medical aid in dying.

Learning Objectives:

1. Integrate the clinical competencies necessary for participating in medical aid in dying and the requirements of aid-in-dying laws (terminology, components, history, data and barriers).
2. Identify how medical aid in dying interfaces with palliative care.
3. Apply a team approach to patient-centered management for end-of-life care.
4. Examine the role of pharmacists in relation to medical aid-in-dying medications and dispensing requirements.
5. Review proper medication protocols for writing prescriptions and other resources, including the use and misuse of opioids.
